Current Issue Vote Results

We wish to thank all of you that returned your Member and Non-Member Ballots. This organization is made up of people from the neighborhood like you and I. By working together, we can have a voice in Local, State and even Federal Government that will have an impact on our lives and those of our children. If you have an interest in becoming involved, please feel free to contact us.

Years ago we stopped holding monthly meetings because of poor attendance. We adopted a policy of conducting votes by phone and appointing committees to study and run with issues. We do, however, hold several meetings each year that pertain to specific problems and invite concerned residents.

Do you think we should hold general meetings quarterly? **Yes 80%, No 16%, No Reply 4%**

If you checked yes, do you think we should we invite guest speakers? **Yes 67%, No 14%, No Reply 19%**

Years ago we held terrific "Meet the Candidate Nights". The candidates each gave a 5 minute speech and everyone mingled. Because of poor attendance we adopted a policy of sending members to interview the candidates and review their backgrounds. Should we hold meet the candidate nights again? **Yes 63%, No 23%, No Reply 14%**

Our charter calls for 9 families to be trustees. Trustee families decide what issues the association will become involved in. They are polled by telephone, converse with each other and render their votes by phone. Currently trustees are elected by membership vote. Should we amend our charter to allow any member who is interested in voting on issues to become a trustee? **Yes 63%, No 29%, No Reply 8%**

Should we encourage the library & town boards to reach a decision on the Armory Park? **Yes 88%, No 7%, No Reply 5%**

Do you support our decision to create local watches and use our county and town relationships to eliminate drug trafficking, illegal activity and thug-like intimidation on blocks in trouble? **Yes 86%, No 5%, No Reply 9%**

Do you support our opposition to workforce (low-income) housing in Nesconset? **Yes 85%, No 10%, No Reply 5%**

Do you support the County's use eminent domain proceedings to remove the trailer park because it obscures the view of Lake Ronkonkoma and interferes with the beauty and enjoyment of the county park resulting in the park being underutilized? **Yes 74%, No 19%, No Reply 7%**

Do you believe the County should remove the trailer park residents because they create an eye sore and the trailer park attracts unsavory elements? **Yes 64%, No 32%, No Reply 4%**

If the County does not remove the trailer park should we convince the town to block the view of the trailer park with tall shrubs and pressure those who conduct illegal activity to find another place? **Yes 74%, No 21%, No Reply 5%**

Regardless of the fact that Nesconset residents don't use the Ronkonkoma Park, should we as an association become involved in cleaning up the Lake Ronkonkoma Park? **Yes 50%, No 47%, No Reply 3%**

Do you have a problem with any of positions we have taken this year? **Yes 1%, No 88%, No Reply 11%**
